# India approves transhipment of Bhutanese goods via Bangladesh

India has granted permission for Bhutanese imports to transit through its territory via Bangla-desh's road network, allowing the country's first official trans-shipment to proceed

The shipment, imported from Thailand by Bhutan's Abit Trading, departed for Bhutan from Burimari

land port on Monday afternoon after Bangladeshi customs completed the necessary formalities. The 6,530-kilogram consignment, which includes fruit juice, jolly, dried fruits, lychee-flavoured candy, and shampoo, had arrived in Bangladesh via Chattogram port on 22 September but faced nearly two months of de-lays while various government clear-ances were processed.
